

## ARTICLE IX Amendments

Amendments to these Articles of Incorporation shall be proposed and adopted in the following manner:

- Notice of the subject matter of a proposed amendment shall be included in the notice of any meeting at which a proposed amendment is considered.
- A resolution approving a proposed amendment may be proposed by either the Board of Directors, or by any one or more members of the Association. Directors, and members not present in person, or by proxy, at the meetings considering the amendment may express their approval in writing, providing such approval is delivered to the Secretary of the Association at, or prior to, the meeting.
- (a) Such approval must be by not less than fifty percent (50%)-of the entire membership of the Board of Directors and by not less than fifty percent (50%) of the entire membership of the Association; or

Except as elsewhere provided, such approvals must be by not less than seventy five percent (75%) of the participating voting interests of the membership of the Association, in person or by proxy or by any other lawful means, at a meeting at which a quorum is established, by written consent in lieu of a meeting, or by any other means permitted by applicable law, where at least a quorum of the membership participates.
