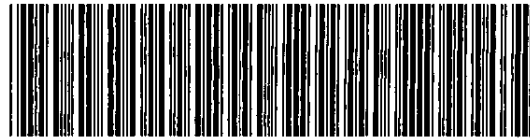

AMENDED ARTICLES OF INCORPORATION MAR 16 PM 4:30

ARTICLE ONE

The name of this corporation is TAFT MISSIONARY BAPTIST CHURCH, INC.

ARTICLE TWO

The general purpose of TAFT MISSIONARY BAPTIST CHURCH, INC., hereinafter referenced to as the Church, shall be to establish and maintain a place for the worship of Almighty God, to provide for Christian Fellowship for those of like precious faith, to assume our share of responsibility and the privilege of propagating the Gospel of Jesus Christ by all available means both at home and in foreign lands, all of which shall be carried out in conformance with the Doctrines and Discipline of the Missionary Baptist Church.

Membership in this Church shall be eligible to all persons who offer themselves for Church Membership. There are three (3) modes of admission, BY BAPTISM, BY LETTER and BY CHRISTIAN EXPERIENCE. The manner of admission to the Church under the three methods aforestated is set forth in the Discipline of the Missionary Baptist Church.

ARTICLE THREE

The term for which this corporation is to exist shall be perpetual.

ARTICLE FOUR

The By-Laws of this corporation shall be as from time to time enacted, authorized and declared by the membership of the Church. The By-Laws shall be added or changed by a one hundred percent (100%) vote of the membership of the Church who are in attendance at any regular or special business meeting of the Church.


ARTICLE NINE

These Articles of Incorporation may be amended or changed by a one hundred percent (100%) vote of the membership of the Church who are in attendance at any regular or special meeting called for that purpose.

ARTICLE TEN

These Amended Articles of Incorporation were adopted by vote of the members of the Church on May 25, 2011, and that one hundred percent (100%) of the members voted to approve these Amended Articles of Incorporation, and such vote was sufficient for approval of these Amended Articles of Incorporation.
