AMENDMENTS TO ARTICLES OF INCORPORATION OF THE FIRST BAPTIST CHURCH OF UMATILLA

Pursuant to the provisions of Florida Statute Chapter **L(1**, the undersigned persons acting upon authorization from the members of the church, hereby amend the Articles of Incorporation of The First Baptist Church of Umatilla, as set forth below:

- 1. Article III of The Articles of Incorporation is hereby amended by replacing the last sentence in Article III with the following sentence: All members of The First Baptist Church of Umatilla shall automatically become members of this corporation.
- Article VI of the Articles of Incorporation is hereby amended by replacing the original Article VI with the following language:

ARTICLE VI

The business affairs of the church shall be managed by a board of five (5) trustees, to be elected by the church at a regular or special business conference each November, to serve a one year term for the ensuing year, beginning January 1. The President, Secretary/Clerk, and the Treasurer of the corporation will occupy three of the positions on the Board of Trustees and the remaining two positions will be held by individuals who are presented by the Nominating Committee and elected by the church.

3. Article VII of The Articles of Incorporation is hereby amended by replacing the original Article VII with the following language:

ARTICLE VII

The Articles of Incorporation and the By-laws of the church may be made, altered, amended or rescinded by a majority vote of the members of the church, present and voting at any regular or special business conference called for that purpose, a quorum being present, provided such amendments have been presented in writing at a previous business conference, and copies of the proposed amendments are available for each member present.

- Article VIII of the Articles of Incorporation which limits the amounted of indebtedness the
 corporation may have at any time, is hereby amended for the purpose of rescinding Article
 VIII in its entirety.
- 5. Article IX of the Articles of Incorporation is hereby amended by renumbering and replacing the original Article IX with Article VIII with the following language:

ARTICLE VIII

The corporation shall have full power to acquire real estate by gift, grant, purchase, devise, exchange, or otherwise, for the use of the church and to hold, possess, enjoy, mortgage, alienate or dispose of the same. No property belonging to the church shall be at any time alienated or encumbered except by a majority vote of the members of the church, present and voting, at a regular or special business conference called for that purpose, with the notice of the time, date, location, and purpose of the meeting being placed in the church bulletin no later than the Sunday prior to the meeting.

These amendments were adopted by a majority vote of the members of the church in a regular business conference held on the 14^{14} day of 1999.
