#### **ARTICLE IX - Amendments**

. Amendments to the Articles of Incorporation shall be proposed and adopted in the following manner:

- 1. Notice of the subject matter of a proposed amendment shall be included in the notice of any meeting at which a proposed amendment is considered.
- 2. A resolution approving a proposed amendment may be proposed by either the majority of the Board of Governors or by not less than twenty-five percent (25%) of the member of the Association, and after being proposed, said amendment must be approved by not less than 18 of the 24 members of the Association. Members not present at a meeting and/or meetings considering an amendment may express their approval in writing. Except as elsewhere provided, such proposed amendment must be approved by the affirmative vote of not less than the majority of the total voting interests in the Association, present and voting, in person, by proxy or by any other lawful means, at a members meeting at which a quorum is present, or by written agreement, provided a quorum participates in the vote by written agreement.
- 3. A copy of each amendment shall be certified by the Secretary of State and recorded in the Public Records of Palm Beach County, Florida.
