ARTICLES OF AMENDMENT

To

ARTICLES OF INCORPORATION

of

MT. GILBOA MISSIONARY BAPTIST CHURCH OF BARTOW, FLORIDA, INC.

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendment Adopted on Article Number II (a) Being Added.

Said corporation is "organized and operated exclusively" for charitable, educational and religious purposes.

Amended Adopted on Article Number II. - (c) Being Added.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of a charitable, educational or religious purpose. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Amendment Adopted on Article Number IV.- (term) Being Amended

Upon dissolution of this corporation assets shall be dissolution of this corporation assets shall be distributed for charitable, educational or religious purposes.
