Articles of Amendment**To****Article of Incorporation of****Jacksonville Urban League Housing, Health And Community Development
Foundation, Inc., a Florida not for profit corporation.****Document Number 717123**

The undersigned, being all the Directors of the above named not for profit corporation in accordance with §617.1006 of the Florida Statutes hereby adopt and agree to this Amendment:

1. A new corporate name was adopted on July 19, 2005 and the name is as follows:
JACKSONVILLE URBAN LEAGUE ECONOMIC AND COMMUNITY DEVELOPMENT
FOUNDATION, INC.
2. The purposes, which this not for profit corporation intends to pursue in Florida, are changed, as follows:

Purposes

The purposes set forth in Section II for which the not for profit corporation is organized are exclusively charitable and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), and shall be operated as follows:

- a) To foster community and economic development and improvement through non-profit sponsorship and procurement of federal, state, local and other programs.
- b) To acquire land, buildings, and other real property by way of purchase, lease, donation, or other real property disposition. To manage, improve/develop, lease and sell these properties for the purpose of generating income to perpetuate the continuation of the same; as well as, to utilize these properties for the provision of affordable housing and services through Urban League sponsored programs.
- c) To develop, repair, and remodel buildings and public works of all kinds and to design necessary and supplemental businesses incidental thereto, or connected therewith, for the furtherance of carrying out the powers and purposes herein mentioned.
- d) To receive gifts, funds and property, to administer the same charitable, educational, civil, and philanthropic uses, and to do anything appropriate for the accomplishment of these purposes.

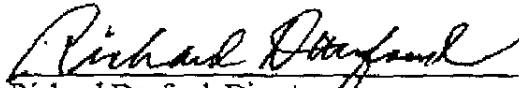

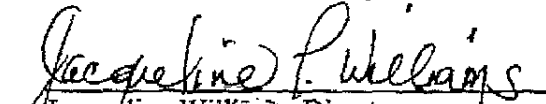

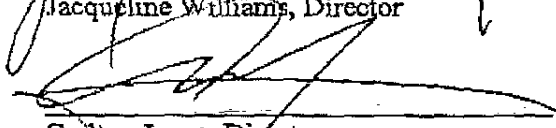
