As stated in the e-mails, we never received any notice regarding a corporation fee and were very distressed when we received the Notice of Administrative Dissolution or Revocation. We worked very hard last year to make sure that all bases were covered since we did not have any experienced board members to guide us. Unfortunately, this is not the type of thing that is in any of the PTA books or addressed at any of the various workshops, at least not that we could find.

All of our mail goes to the school and is then distributed to us. The office staff completes distribution, except for during the summer, when only the Principal sorts through the mail. The Principal has verified that they have never seen any mail come from the Florida Department of State for the PTA or for anyone for that matter.

Your office advised me, that if I explain the situation to you in a letter the reinstatement fee would be waived. Therefore, we respectfully request the waiver of the reinstatement fee on the basis that we never received any of the prior notices.
