



## AMENDMENT TO ARTICLES OF INCORPORATION

OF

ORANGE PARK COMMUNITY THEATRE, INC. (A Corporation Not for Profit) 7/7299

Pursuant to Chapter 617.02, Florida Statutes, the undersigned Not for Profit Corporation adopted the following Amendment to its Articles of Incorporation:

The undersigned Not for Profit Corporation, which received its Charter on October 6, 1969, and amended said Charter on March 14, 1973 hereby resolves that The Articles of Incorporation be further amended as follows:

### **ARTICLE VIII, BYLAWS Section 2**

Upon proper notice the bylaws may be amended, altered or rescinded by a majority vote of those members present at any regular meeting or any special meeting called for that purpose that has a quorum present. Quorum is defined as an attendance of members equal to two-thirds (2/3) of the number of Board positions AND at least one third (1/3) of the board members must be present.

### ARTICLE IX, AMENDMENTS TO ARTICLES OF INCORPORATION Section 1

These Articles of Incorporation may be amended at a special meeting of the members called for that purpose, by a two-thirds (2/3) vote of those present provided that a quorum is present. Quorum is defined as an attendance being equal to two-thirds (2/3) of the number of Board positions AND at least one third (1/3) of the board members must be present.

### ARTICLE IX, AMENDMENTS TO ARTICLES OF INCORPORATION Section 2

Amendments to the Articles of Incorporation may also be made at the annual meeting of the membership upon notice given, as provided by the bylaws of intention to submit such amendments provided a quorum is present AND that at least one-third (1/3) of the Directors of the Board are present. Quorum is defined as an attendance of members equal to two-thirds (2/3) of the number of Board positions AND at least one third (1/3) of the board members must be present.

### **ARTICLE X, LOCATION Section 1**

The physical location of this corporation is 2900 Moody Ave, Orange Park, Florida, 32073. The mailing address of this corporation shall be the official address filed with the U.S. Post Office. On January 13, 2015, the address was Post Office Box 391, Orange Park, Florida, 32067-0391.


