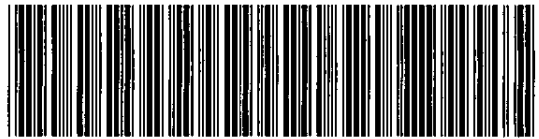


The Board of Directors of Fort Lauderdale Community Church, Inc., met on October 14, 2007, and a quorum being present, the following amendments were adopted:
