


**ARTICLE XIII**

The members, officers, trustees, board members and, or, directors of Apostolic Miracle Temple Inc. or other private persons shall not receive benefit of income from the corporation, except that the corporation shall be authorized to pay reasonable compensation for services rendered and make payments and distributions in furtherance of the purposes of the corporation pursuant to Article II and Article XII of these Articles. Further, no substantial activity of the corporation shall be for the purpose of promoting propaganda, influence of legislation or political campaign activity, including publishing and distributing statements for those activities. Notwithstanding any other provisions of these Articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

## ARTICLE XIV

Notwithstanding Article IV, should this corporation become subject to dissolution, any asset(s) distribution shall be for an exempt purpose within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future tax code, or shall be distributed to the federal, state or local government for public use, or be disposed by a Court of Competent Jurisdiction of the county in which the principal office of this corporation is then located, exclusively for such purposes or to such organization(s) as said Court shall determine, which are organized and operated exclusively for such purposes.

In Witness whereof, we have hereunto set our hand and seal to the above ARTICLE NUMBERS XIII and XIV BEING ADDED by Articles of Amendment this 9<sup>th</sup> day of July 2001.
