#### Amendment to Article II

The general nature and purpose of this corporation shall be to promote knowledge of the functions, resources services and needs of the Central Library; to support the development of a program for the extension and improvement of library services and resources; to aid in the provision for adequate library facilities; to encourage gifts, endowments and memorials for the Central Library; to raise funds to be applied toward the accomplishments of the purposes of the corporation. Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organization that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

# Friends of the Central Library Special Membership Meeting Friday, November 9, 2012 at 1:00 P.M.

The meeting was called to order by President Lois Flagg at 1:00 P.M.

Treasurer Judy Wetter introduced the language of the revision to the Articles of Incorporation.

Article II reads:

The general nature and purpose of this corporation shall be to foster closer relations between the Bradenton Library, Manatee County Libraries and the citizens of Bradenton; to promote knowledge of the functions, resources services and needs of the libraries; to lead in the development of a program for the extension and improvement of library services and resources; to aid in the provision for adequate library facilities; to encourage gifts, endowments and memorials for the Bradenton library; to raise funds to be applied toward the accomplishments of the purposes of the corporation; provided, however, that this corporation shall not engage in any activity or make any distribution prohibited by 1954 Internal Revenue Code section 501(c)(3), or the corresponding of any future United States Internal Revenue Law.

The amendment would read:

The general nature and purpose of this corporation shall be to promote knowledge of the functions, resources services and needs of the Central Library; to support the development of a program for the extension and improvement of library services and resources; to aid in the provision for adequate library facilities; to encourage gifts, endowments and memorials for the Central Library; to raise funds to be applied toward the accomplishments of the purposes of the corporation. Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organization that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
