ARTICLES OF AMENDMENT
to
ARTICLES OF INCORPORATION
of

VOLUSIA EDUCATORS ASSOCIATION, INCORPORATED

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

ARTICLE IX, Dissolution is amended to read:

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, convey all of the remaining assets of the corporation exclusively to the FTP-NEA and FTP-NEA holding corporation, Inc., organizations exempt under section 501 (c) (5) of the Internal Revenue Code, as amended, or the corresponding provision of any future United States Internal Revenue law (as the Board of Directors shall determine.)
