AMENDMENT TO ARTICLES OF INCORPORATION OF EL JOBEAN WATER ASSOCIATION, INC.

We, the undersigned, being the properly elected directors of El Jobean Water Association, Inc. (the "Association") hereby and herewith revise by amendment those certain Articles of Incorporation of the Association, heretofore filed on March 24, 1970 with the Florida Secretary of State, Division of Corporations, as follows:

Article II is hereby amended to read as follows:

ARTICLE II

The nature of the business of the corporation and the purposes for which it is organized are:

- A. To construct, When developers or agency lines are in place, then the corporation will maintain and operate a water system for the supplying of water for domestic, commercial, agricultural, industrial, and other purposes to its members and for the sale of any surplus water remaining after the needs of its members have been satisfied and to engage in any activity relating related thereto, including but not limited to the acquisition of water by appropriation, drilling, pumping, purchase or otherwise, and the purchase, laying, institution, operation, maintenance, and repair of wells, pumping equipment, water mains, pipelines, valves, meters, and all other equipment necessary or useful to the construction, maintenance and operation of a water system; and
- B. To construct, maintain, and operate a sewage disposal system for the use and benefit of its members.

C.—It is the purpose of this corporation to serve and accept as members inhabitants of that portion of the area of Charlotte County, Florida, lying between the waters of Charlotte Harbor and the Myakka River which is generally known as El Jobean; but the business and activities of the corporation may be conducted at any place in the State of Florida or elsewhere.
