**ARTICLES OF DISSOLUTION  
FOR  
AURORA MINISTRIES, INC.  
A Florida Not for Profit Corporation**

Pursuant to 617.1403, Florida Statutes, AURORA MINISTRIES, INC., a Florida not for profit corporation, whose Articles of Incorporation were filed on August 13, 1970 and assigned document number 718999, submits the following Articles of Dissolution:

1. The name of the Corporation is AURORA MINISTRIES, INC.
2. The Corporation has no members. The resolution to dissolve the Corporation was adopted by the Directors at a meeting of the Board of Directors on April 26, 2022. The number of Directors then in office is seven (7). The votes cast for the resolution to dissolve was six (6) votes in the affirmative (which included all Directors present at the meeting) and the seventh Director was absent from the meeting. The number of votes cast for the dissolution was sufficient for approval.
3. All debts, obligations and liabilities of the Corporation have been paid and discharged, or adequate provision has been made therefore.
4. All remaining property and assets have been or will be distributed to charitable organizations, as provided in the Articles of Incorporation.
5. There are no suits pending against the Corporation in any court in respect of which adequate provision has not been made for the satisfaction of any judgment, order or decree which may be entered against it.
6. The effective date of these Articles of Dissolution shall be June 30, 2022.
