ADOPTED AMENDMENTS TO ARTICLES OF INCORPORATION OF INNISBROOK CONDOMINIUM ASSOCIATION, INC.

The following are adopted amendments to the Articles of Incorporation of Innisbrook Condominium Association, Inc., which is an exhibit to the Declaration of Condominiums 1 through 28 of Innisbrook Condominiums, such Articles of Incorporation being originally recorded at Official Records Book 4245, Page 1146, Public Records of Pinellas County, Florida.

Item No. 1: Section 3.2f of the Articles of Incorporation is hereby amended to read as follows:

ARTICLE 3

Powers

The powers of the Association shall include and be governed by the following provisions:

* * *

- 3.2 The Association shall have all of the powers and duties set forth in the Condominium Act except as limited by these Articles and the respective Declaration of Condominium, and all of the powers and duties reasonably necessary to operate the condominium pursuant to the Declaration and as they may be amended from time to time, including but not limited to the following:
- f. To make and amend reasonable regulations governing the use of Units, Common Elements, Limited Common Elements, Association Property and the operation of the Association, provided that such rules and regulations are not in conflict with the Declaration or By-Laws.
- Item No. 2: Section 5.1 of the Articles of Incorporation is hereby amended to read as follows:

ARTICLE 5

Directors

5.1 The affairs of the Association will be managed by a board consisting of the number of directors determined by the By-Laws, but not less than three directors, and in the absence of such determination shall consist of three directors. Directors' qualifications are as provided in the By-Laws.
