ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
SPRING LAKE TOWERS MANAGEMENT, INC.

Pursuant to the provisions of §617.1006, *Fla.Stat.*, Spring Lake Towers Management, Inc., adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: Amendment(s) adopted:

Article I, Section 1, Article II, Section 2 and Article VI, Sections 2 and 3 of the Articles Of Incorporation Of Spring Lake Towers Management, Inc., are hereby amended as follows (note that additions are indicated by underlining and deletions are indicated by ~~strikeouts~~:

ARTICLE I

Name and Location

Section 1. The name of this corporation shall be SPRING LAKE TOWERS MANAGEMENT, INC., ~~a Condominium~~; and the principal office shall be in Polk County, Florida. The address of the corporation is 700 Mirror Terrace, N.W., Winter Haven, Florida 33881.

ARTICLE II

Purposes

Section 2. No part of the income of this corporation shall be distributed to its members, directors or officers. Nothing herein shall preclude the compensation of the manager of Spring Lake Towers, a

Condominium by Spring Lake Towers Management, Inc.

ARTICLE VI

Management and Time of Election

Section 2. Directors shall be elected by the Voting Members in accordance with the Bylaws at the regular annual meeting of the membership of the corporation to be held at ~~2:00 P.M. on the second Monday~~ in January ~~in~~ of each year at such time and on such date as determined by the Board of Directors. Directors shall be elected to serve for a term staggered terms of one year two (2) years. In the event of a vacancy, the elected Directors may appoint an additional director to serve the balance of said year.

Section 3. At the conclusion of each annual meeting, a meeting of the Board of Directors shall be convened which shall have as one of its purposes the election of officers. All officers shall be elected by the Board of Directors in accordance with the Bylaws ~~at the regular annual meeting of the Board of Directors on the second Monday in January in each year, to be held immediately following the annual meeting of the membership.~~ The Board of Directors shall elect from among the ~~members~~ Directors a President, Vice President, ~~Secretary-Treasurer~~ Secretary, and Treasurer and such other officers as it shall deem desirable.

SECOND: The date of adoption of the Amendment(s) was June 27, 2001.

THIRD: Adoption of Amendment

Article X of the Articles of Incorporation entitled "Amendment of Articles of Incorporation", as amended, provides that: "Any ten (10) members of the corporation may propose amendments to the Articles of Incorporation, provided however, that an affirmative vote of fifty-three (53) or more of the qualified Voting Members of the corporation shall be necessary to adopt such proposed Amendments."

The members of the corporation were entitled to vote on the Amendment(s), and the Amendment(s) were duly adopted by the members, in accordance with the above-stated provision. The number of votes cast for the Amendment(s) was sufficient for approval.
