- 1. Name of Corporation. The name of the Corporation is LEE ISLAND COAST ASSOCIATION OF REALTORS®, INC.
- 2. Amendments Adopted. As permitted by ARTICLE J of the Articles of Incorporation, the Articles of Incorporation were amended by the unanimous consent of the Board of Directors on May 11, 1999, as follows:

Article A of the Articles of Incorporation is deleted entirely and the following is substituted in its place:

ARTICLE A

Name

The name of this Corporation is REALTOR® ASSOCIATION OF GREATER FORT MYERS AND THE BEACH, INC.

The number of votes cast for the amendment were sufficient for approval.

3. Members Not Entitled to Vote. ARTICLE J of the Articles of Incorporation provides that the Articles of Incorporation are to be amended by a majority vote of the Board of Directors at a meeting called for that purpose. Members are not entitled to vote.
