

### SPECIAL RULE REGARDING DOCK USAGE AT BAY TREE CLUB

The Bay Tree Club Board of Directors has previously promulgated rules regarding dock usage at Bay Tree Club. Those rules remain in full force and effect. The Board, by unanimous vote, adopts the following special rule for dock usage in addition to the previous rules:

> Pursuant to Environmental Resource Permit No. 58-0188117-002, slips A-1 through A-12 and B-1 through B-10 shall be designated for non-motorized vessels only. No motorized vessels shall be allowed in these slips.

This rule will be filed with Secretary of State for the State of Florida as an addendum to the Amendment of the Bay Tree Declaration of Condominium previously filed on February amending Article 5(B)(4) which added the following language to the declaration of condominium:

The docking facility is subject to State of Florida Lease No. 58000803.
