ARTICLES OF INCOMPANION OF WEST PARM BEALH

AMATEUR Amendments Adopted

TITLE

DELETE: 3rd line 5th word "CLUB"

REPLACE WITH: "GROUP"

PREAMBLE

INSERT: "and as specified in Section 501(c) 3 of the Internal Revenue Code,"

BETWEEN: "Statutes, and "do"

ARTICLE I:

CHANGE line 2: 5th word "CLUB" to "GROUP"

ARTICLE II: PURPOSES:

DELETE line 1-12; "The general nature of the objects and purposed of this corporation shall be:" to "public welfare and community interest"

REPLACE WITH: "To the extent permitted by Code Section 501(c) (3), and as authorized by the Federal Communications Commission (FCC), the Corporation is organized exclusively for the following purposes: charitable, scientific, testing for public safety, literary, educational purposes and to foster local, national and international amateur radio cooperation and competition. All references to "Code" are to the Internal Revenue Code of 1986 as amended or to corresponding provisions of future federal tax legislation;

ADD SECTION "LIMITATIONS"

"No part of the net earnings of the Corporation shall inure to the benefit of (or be distributable to) its directors, officers, members or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of any of its purposes. No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, except as otherwise provided in Code Section 501(h). The Corporation shall not participate

or intervene in any political campaign (including the publishing or distributing of statements) on behalf of any candidate for public office. Notwithstanding any other provision of these Articles of Incorporation, the Corporation shall not carry on any activities except those permitted to be carried on by a corporation exempt from federal income tax under Code Section 501(c)(3) or by a corporation contributions to which are deductible under Code Section 170(c)(2)."

"If the Corporation is at any time deemed to be a private foundation within the meaning of Code Section 509(a), then for the period in which the Corporation is so deemed, the Corporation shall distribute its income for each tax year at such time and in such manner as not to subject the Corporation to tax under Code Section 4942, and the Corporation shall not engage in any act of self dealing as defined in Code Section 4941(d), retain any excess business holdings as defined in Code Section 4943(c), make any investments as to subject the Corporation to tax under Code Section 4944 or make any taxable expenditures as defined in Code Section 4945(d)."

ADD NEW ARTICLE XIII

"ARTICLE XIII DISSOLUTION"

"Upon the dissolution or winding up of the Corporation, the assets remaining after payment (or provision for payment) of the Corporation's debts and liabilities shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose."
