AFFIDAVIT OF FORMER REGISTERED AGENT

BEFORE ME, the undersigned authority did appear DAVID IGLESIAS, who, deposes and states the following under penalties of perjury:

- 1. My name is David Iglesias, I am over the age of eighteen (18), and I am an attorney licensed to practice law in the State of Florida.
 - 2. I am the President of Iglesias Law Group, P.A..
- 3. I make this Affidavit based on my personal knowledge, based on facts which are known to me.
- 4. Iglesias Law Group, P.A. primarily represents condominium associations and homeowners' associations as their general counsel.
- 5. Iglesias Law Group, P.A. formerly represented Island Breakers A Condominium, Inc., [Document Number 720000] until March 29, 2022.
- 6. On or about April 20, 2022, Iglesias Law Group, P.A. filed its Resignation Registered Agent form, and paid the fee of \$87.50 to remove itself as the Registered Agent for Island Breakers A Condominium, Inc., [Document Number 720000].
- 7. Iglesias Law Group, P.A.'s resignation as Registered Agent appears on the Sunbiz.org page for Island Breakers A Condominium, Inc., [Document Number 720000], and is dated April 25, 2022.
- 8. It appears, based on the publicly available records found on Sunbiz.org, that on June 24, 2022, Iglesias Law Group, P.A. was again listed as the Registered Agent for Island Breakers A Condominium, Inc., [Document Number 720000], with the purported electronic signature of "DAVID IGLESIAS. ESQ."
- 9. I declare, under penalties of perjury, that I did not submit the June 24, 2022, Amended Annual Report, nor did I authorize my electronic signature to be placed upon the

Amended Annual Report filed for Island Breakers – A Condominium, Inc., [Document Number 720000] on that date.

- 10. Based on the publicly available records found on Sunbiz.org, on September 9, 2022, a second Amended Annual Report was filed for Island Breakers A Condominium, Inc., [Document Number 720000], listing "DAN WOODRUFF."
- 11. Based on the publicly available records found on Sunbiz.org, on June 20, 2023, Island Breakers A Condominium, Inc., [Document Number 720000] filed a second Amended Annual Report which lists "DAVID IGLESIAS. ESQ." as the Registered Agent, and purports to be electronically signed by "DAVID IGLESIAS, ESQ."
- 12. I declare, under penalties of perjury, that I did not submit the June 20, 2023, Amended Annual Report, nor did I authorize my electronic signature to be placed upon the Amended Annual Report filed for Island Breakers A Condominium, Inc., [Document Number 720000] on that date.
- 13. Based on the publicly available records found on Sunbiz.org, on February 9, 2024, Island Breakers A Condominium, Inc., [Document Number 720000] filed its Annual Report which lists "DAVID IGLESIAS. ESQ." as the Registered Agent, and purports to be electronically signed by "DAVID IGLESIAS, ESQ."
- 14. I declare, under penalties of perjury, that I did not submit the February 9, 2024, Annual Report, nor did I authorize my electronic signature to be placed upon the Annual Report filed for Island Breakers A Condominium, Inc., [Document Number 720000] on that date.
- 15. Based on the publicly available records found on Sunbiz.org, on February 15, 2024, Island Breakers A Condominium, Inc., [Document Number 720000] filed an Amended Annual Report which lists "DAVID IGLESIAS. ESQ." as the Registered Agent, and purports to be electronically signed by "DAVID IGLESIAS, ESQ."

16. I declare, under penalties of perjury, that I did not submit the February 15, 2024, Amended Annual Report, nor did I authorize my electronic signature to be placed upon the Amended Annual Report filed for Island Breakers – A Condominium, Inc., [Document Number 720000] on that date.

17. I was not made aware that I had been listed as the Registered Agent for Island Breakers – A Condominium, Inc., [Document Number 720000] until a vendor for the association contacted my office under the mistaken belief that I am the Registered Agent.

18. Neither I nor any employees of Iglesias Law Group, P.A. have had contact with Island Breakers – A Condominium, Inc., [Document Number 720000] since the termination of my firm's representation of the association on March 29, 2022, and I certainly have not authorized or consented to Island Breakers – A Condominium, Inc., [Document Number 720000] listing me as its Registered Agent.
