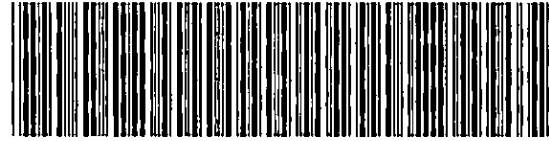

In the event of the dissolution of the First Church of the Nazarene of Clearwater, Inc., the residual assets of the corporation will be distributed by the District Advisory Board of the Florida District Church of the Nazarene as

provided by the Manual of the Church of the Nazarene.

Article VIII The Corporation shall provide By-Laws for its government not inconsistent with these Articles of Incorporation, the laws of the State of Florida and the United States, nor inconsistent with the government and discipline of the Church of the Nazarene as may be from time to time provided in the official Manual of said Church.


