The present Article IV is revoked and in its place the following to be substituted:
ARTICLE IV
BOARD OF DIRECTORS AND OFFICERS
SELECTION AND TERM OF OFFICE
Section 1. The affairs of the Association (Corporation) shall be managed by a Board of Directors of not more than twelve
or less than nine. Directors shall be elected for two year terms at the annual membership meeting as hereby specified.
One half of the Directors (plus one if the total number of Directors is an odd number) serving in 2016 shall serve
for two years, and the remaining Directors serving in 2016 shall serve for one year. Thereafter: on each succeeding even
numbered year, one half of the total number of Directors (plus one if the total number of Directors is an odd number) shall be
elected; and, on each odd numbered year, the other half of the total number of Directors shall be elected. And Director may
succeed themselves for as many additional terms as such Director is elected by the membership. the Board of Directors from
among its membership shall elect a President, a Vice-President, a Secretary, and a Treasurer. the officer's term shall
coincide with their term as Director.
