

# AMENDMENT TO AMENDED AND RESTATED ARTICLES OF INCORPORATION OF LEEWARD COVE CLUB, INC.

Additional language indicated by <u>underlining</u>. Deleted language indicated by <del>hypbens</del>.

Article VII(C) of the Amended and Restated Articles of Incorporation is amended as follows:

(C) Except as otherwise provided by law, a proposed amendment must be approved by at least 2/3 3/4 of the Voting Interests, provided that notice of the proposed amendment has been given to the Members in accordance with the Condominium Act and the Bylaws. These Articles shall be deemed amended by virtue of revisions to statutes and regulations which control over conflicting provisions of these Articles. The Board of Directors shall have the authority to amend these Articles in order to conform the provisions thereof with such revisions to statutes and regulations. In addition, the Board of Directors may amend these Articles to correct serivener's errors or omissions, and amend and restate these Articles in order to consolidate into one document amendments previously adopted by the members or the Board of Directors. Amendments adopted by the Board of Directors shall occur at a duly noticed Board of Directors meeting (with adoption of the amendments set forth on the agenda). The Board of Directors shall supply the Members with a copy of the adopted amendments.
