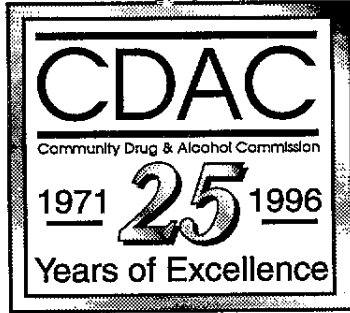

Article II - PURPOSE

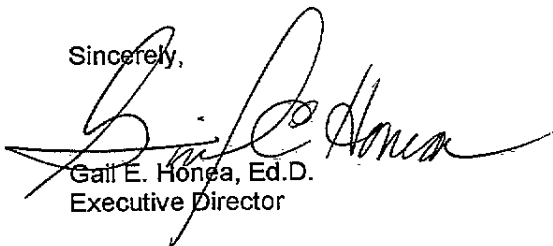
The purposes for which the corporation is organized are as follows:

TO
