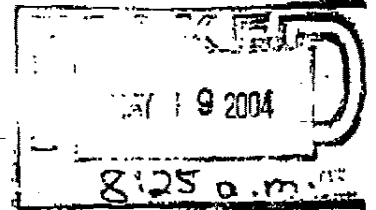

ARTICLES OF MERGER  
OF  
CORNERSTONE CHURCH OF THE SUNCOAST, INC.  
INTO  
RESTORATION FELLOWSHIP, A CORNERSTONE CHURCH, INC.

Pursuant to the provisions of Florida Statutes Section 617.1105 of the Florida Business Corporation Act (the "Florida Act"), these Articles of Merger are entered into this 14<sup>TH</sup> day of September, 2003, by and between the undersigned corporations, who adopt the following Articles of Merger for the purpose of merging Cornerstone Church of the Suncoast, Inc., a Florida nonprofit corporation ("Merged Corporation"), into Restoration Fellowship, A Cornerstone Church, Inc., a Florida nonprofit corporation ("Surviving Corporation"):

The Plan of Merger is as follows:

1. The surviving corporation will be Restoration Fellowship, A Cornerstone Church, Inc.
2. Restoration Fellowship, A Cornerstone Church, Inc. will assume all of the assets and liabilities of Cornerstone Church of the Suncoast, Inc., pursuant to Florida Statute Section 617.1106.
3. Cornerstone Church of the Suncoast, Inc. shall cease to exist as a separate corporation.

The members of each Corporation entitled to vote approve the Plan of Merger.

The membership of Cornerstone Church of the Suncoast, Inc. approved said Plan of Merger at a meeting duly called for such purpose with notice as required by the Bylaws of the Corporation on September 14, 2003. The number of votes cast was sufficient for approval. All such voting was conducted in accordance with the Florida act. No votes were made against the Plan.

The membership of Restoration Fellowship of Sarasota, Inc. approved said Plan of Merger at a meeting duly called for such purpose with written notice as required by the Bylaws of the Corporation on September 14, 2003. The number of votes cast was sufficient for approval. All such voting was conducted in accordance with the Florida act. No votes were made against the Plan.

The effective date of this merger shall be at such time as these Articles of Merger shall be filed by the Secretary of State of the State of Florida.




PLAN OF MERGER
