## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF FIRST ASSEMBLY OF GOD, INC.

100 L. 100 L. 100 PM 12:42 Pursuant to the provisions of Section 617.1006 of the Florida Statutes, FIRST ASSEMBLY OF GOD, INC., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:
