- THIRD: Dissolution in accordance with Chapter 617, Florida Statutes, and the Plan of Distribution of Assets attached hereto as Exhibit "A" was authorized by the Members of the Corporation on December 21, 2011, and the number of votes was sufficient for approval.
- FOURTH: The effective date of dissolution is December 31, 2011.

PLAN OF DISTRIBUTION OF ASSETS

THIS PLAN OF DISTRIBUTION OF ASSETS (this "*Plan*") is made and approved by the members and the Board of Directors of NEW LIFE ASSEMBLY OF GOD ORLANDO, INC., a Florida not-for-profit corporation (the "*Church*") this 21 day of December, 2011.

A. At a Special Business Meeting of the Church held on Thursday, November 3, 2011, the church unanimously voted to become a campus church of Faith Assembly of God of Orlando, Inc. ("*Faith Assembly*"). The leadership of the Church, including its Pastor and Board of Directors have determined that to more efficiently implement the decision to become a campus church of Faith Assembly the Church should formally dissolve pursuant to §617.1402, *Florida Statutes*, and distribute its assets in accordance with the following Plan of Distribution of Assets.

B. As such, upon the recommendation of the Board of Directors, the Church hereby approves, authorizes and consents to the following Plan of Distribution of Assets in accordance with §617.1406, *Florida Statutes*.

1. The Church has made arrangements for all liabilities and obligations of the Church to be paid and discharged, or adequate provisions otherwise made therefor, as described in the attached Exhibit A.
2. Upon receipt of the consent of the Peninsular Florida District of the Assemblies of God, the assets of the Church remaining after adequate provision has been made for outstanding liabilities and obligations shall be distributed to Faith Assembly, which is a church affiliated with the Peninsular Florida District of the Assemblies of God and is engaged in activities substantially similar to those of the Church.
3. Pastor Gloria G. Reeves and the duly appointed officers of the Church are hereby authorized, empowered and directed to implement and effectuate such distribution by undertaking the following actions on behalf of the Church immediately:
 - a. execute and deliver a Quit Claim Deed to Faith Assembly for all real property owned in whole or in part by the Church;
 - b. execute and deliver an Assignment and Bill of Sale to Faith Assembly for all other assets of the church, including but not limited to all of the Church's tangible and intangible personal property, cash in accounts, deposits, telephone numbers, and the name "New Life Assembly of God Orlando."
4. Pastor Gloria G. Reeves and the duly appointed officers of the Church are hereby authorized, empowered and directed to take any and all other actions deemed necessary to implement and put into effect this Plan of Distribution of Assets and they are further authorized, empowered and directed to execute any and all documents on behalf of the Church in connection therewith.
5. All tangible personal property, if any, held by the Church upon condition requiring return, transfer, or conveyance, which condition occurs by reason of the dissolution, is to be returned, transferred, or conveyed in accordance with such requirements.
