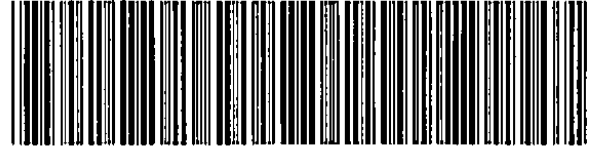

ARTICLE VII

BOARD OF DIRECTORS

A. The Association shall be managed by a Board of Directors, consisting of the number of directors determined by the By-Laws, as amended from time to time, but not less than three (3) Directors, and in the absence of such determination shall consist of three (3) Directors. ~~The members of the first Board of All Directors need not~~ shall be Mmembers of the Association.

C.
