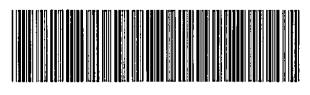

ARTICLE VII

BOARD OF DIRECTORS

A. The Association shall be managed by a Board of Directors, consisting of the number of directors determined by the By-Laws, as amended from time to time, but not less than three (3) Delirectors, and in the absence of such determination shall consist of three (3) Delirectors. The members of the first Board of All Directors need not shall be Mmembers of the Association.

C.
