

The Articles of Incorporation of Y.C.C.S. Property Owners' Association, Inc. were filed with the Florida Secretary of State on September 24, 1971, amended at OR Book 1992, Page 2296 et seq., and Amended and Restated on June 5, 2015 at OR Book 2788, Page 164 et seq., Public Records of Martin County, Florida. The same Amended and Restated Articles of Incorporation are hereby amended as approved by not less than two-thirds (2/3) of the Members present at the meeting held on February 24, 2020.

1. Article IX and Article X are amended to read as follows:

## ARTICLE IX. By-Laws.

The Association may annul, waive, change or modify any of the restrictions, covenants, agreements and provisions contained in the By-Laws with the consent of the majority in number of the then owners of all Dwelling Units in the Subdivision. In computing the majority, each Dwelling Unit shall be entitled to one vote, irrespective of the number of its owners. Said consent may be expressed by written consent or by a vote cast (in person or by proxy) at a meeting of the Members of the Association.

## ARTICLE X. Amendments

The Association may annul, waive, change or modify any of the restrictions, conditions, covenants, agreements and provisions contained in these Articles of Incorporation with the consent of the majority in number of the then Owners of all Dwelling Units in the Subdivision. In computing the majority, each Dwelling Unit shall be entitled to one vote, irrespective of the numbers of its owners. Said consent may be expressed by written consent of by a vote cast (in person or by proxy) at a meeting of the Members of the Association.

(The Balance of the Articles of Incorporation remains unchanged.)

2. The foregoing amendments to the Articles of Incorporation of Y.C.C.S. Property Owners' Association, Inc. were approved by not less than two-thirds (2/3) of the Members present at the meeting held on February 24, 2020, which vote was sufficient for approval.
