

- 1. The name of this Corporation is SACRED HEART CUBAN ALUMNAE ASSOCIATION, INC. (hereinafter called the "Corporation").
- 2. Article II of the Corporation's Articles of Incorporation is deleted and replaced by new Article II, as follows:
