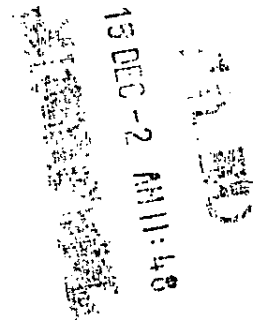

Effective as of October 31, 2015 and pursuant to Section 617.1403, Florida Statutes, this Florida not for profit corporation, adopts the following articles of dissolution for the purpose of dissolving the corporation:

First: The name of the corporation as currently filed with the Florida Department of State is Pasco Italian American Civic Club, Inc.

Second: The document number of the corporation is 722466.

Third: The vote to dissolve the corporation was adopted at a meeting of the members held on May 4, 2015, and received the vote of the majority of members in attendance at the meeting and entitled to vote.
