

The Amended and Restated Articles of Incorporation of

Florida State College at Jacksonville Foundation, Inc.

We, whose names are affixed hereto, do hereby associate ourselves together for the purposes of forming a corporation not for profit under the laws of the State of Florida and under the following Articles of Incorporation:

Article I

The name of this corporation is Florida State College at Jacksonville Foundation, Inc.

Article II

The purposes for which this corporation is organized are as follows:

- a) Florida State College at Jacksonville Foundation, Inc. (the "Foundation") is a "Florida College System Institution Direct Support Organization" as purposed under FS. 1004.70, incorporated as a Florida "Corporation Not-for-Profit" under the provisions of Chapter 617, Florida Statutes, and "Certified" by the District Board of Trustees of Florida State College at Jacksonville (the "District Board of Trustees" or "College") to receive, hold, muster, invest, and administer property, and to make expenditures to or for the exclusive benefit of Florida State College at Jacksonville.
- b) The exercise of any one or more of the powers, duties or responsibilities of the corporation shall be done in the furtherance of the exempt purposes of the corporation as provided under the Internal Revenue Code of the United States.

Article III

The principal office of the corporation in the State of Florida is:

Florida State College at Jacksonville Foundation, Inc. 501 West State Street, Suite 104 Jacksonville, Florida 32202

The resident agent and address for the corporation is:

General Counsel Florida State College at Jacksonville 501 West State Street, Suite 403 Jacksonville, Florida 32202

The Board of Directors may from time to time move the principal office to any other address in Florida.

Article IV

The membership of the corporation shall consist of the individuals constituting the Board of Directors.

Article V

The corporation shall have perpetual existence. If the corporation should be dissolved, all of its assets shall be distributed to Florida State College at Jacksonville or its successors.

Article VI

Section 1. Board of Directors

The affairs of the Foundation shall be managed by a Board of Directors of not less than fifteen (15) members. Their number, qualifications, terms of office and manner of selection shall be fixed in the Bylaws.

Section 2. Executive Committee

The Board of Directors may provide for the formation of an Executive Committee. The authority of the Executive Committee shall be as prescribed in the Bylaws of the corporation.

Section 3. Officers

The officers of the corporation shall be the officers of the Board of Directors, the College President, and the corporation's Executive Director.

Article VII

These amended Articles of Incorporation may be revised or amended at any regular or special meeting of the Board of Directors, where a quorum has been established, by a 2/3rd (66%) majority vote of the members present and voting.

Article VIII

The Bylaws of the corporation are to be made, altered or rescinded by the Board of Directors in the manner set forth in the Bylaws.

IN WITNESS WHEREOF, the undersigned Chair and Secretary, do make and file these amended and restated Articles of Incorporation of Florida State College at Jacksonville Foundation, Inc., a corporation not-for-profit, formed pursuant to Chapter 617, Florida Statutes, by declaring and certifying that the facts herein stated are true. These amended and restated Articles of Incorporation were adopted by the membership on the corporation on this 21st day of September, 2016. The number of votes cast were sufficient for approval.
