1. Add Article numbers to the whole corporation paper.
 2. Article I NAME: Not change in the name except listing it as article I
 3. Article II PRINCIPAL OFFICE: 3450 South Biscayne Drive, North Port, FL. 34287
 4. Article III PURPOSE; Amend the word "mankind" to "humanity"
 5. Article IV QUALIFICATIONS: Amend this statement by removing the last part "whose approval shall be required for admission into the church" and substitute the words "or to the pastor".
 6. Article V TERM: Leave this statement unchanged except numbering the article.
 7. Article VI OFFICERS: Replace this whole paragraph with the following paragraph: "The corporation officers will be the entire church council and it shall serve as the executive body of the congregation with the powers of the church between meetings of the congregation."
 8. Article VII EXECUTIVE COMMITTEE: Replace the whole paragraph with the following: "Any of the following corporation officers may be designated to sign bank accounts and corporation papers: Moderator, Vice Moderator, Treasurer, Clerk or Trustee Chairperson."
 9. Remove the next paragraph entitled Board of Directors.
 10. Article VIII THE FIRST BOARD OF DIRECTORS. Leave this unchanged except for listing it as article VIII.
 11. Article IX Amend the title "The Officers" to "Elections" and change the last word "January" to read "December".
 12. Article X Insert the title "First Temporary Officers" and leave the rest unchanged.
 13. Article XI BY-LAWS: Leave unchanged except listing it as Article XI
 14. Article XII AMENDMENTS: Leave unchanged except listing it as Article XII
