ARTICLES OF INCORPORATION  
OF  
LAKELAND-POK HOUSING CORPORATION, INC.

The undersigned who are natural persons and who are citizens of the United States; of the age of twenty-one years or more, desiring to form a Corporation, not-for-profit, under and pursuant to the laws of the State of Florida, as amended do hereby certify:

ARTICLE I

The name of the Corporation to LAKELAND-POK HOUSING CORPORATION, INC.

ARTICLE II

The purpose or purposes for which said Corporation is formed are to be purely charitable with the ultimate aim of promoting improvement and well-being of man. The purposes are:

To promote and advance low-rent housing in the City of Lakeland, Florida, as an agency and instrumentality of the Housing Authority thereto by, among other things, rendering financial assistance to the Housing Authority by financing and constructing in or near the City of Lakeland one or more buildings usable for public housing purposes of the City or other purposes not inconsistent therewith.

ARTICLE III

The Corporation shall not afford pecuniary aid, incidentally or otherwise, to its workers or directors.

ARTICLE IV

The powers of the Association shall include and be governed by the following provisions:

(a) To acquire by lease, purchase, lease-back or otherwise real estate at any interest therein located in or near the City of Lakeland to construct or otherwise acquire and own buildings and structures which may be utilized by the Housing Authority for low-rent housing and other civic purposes authorized by law; and (by sale, lease, sublease or otherwise); to make any part or all of such properties available to or for the benefit of the Housing Authority or its lawful successor or successors, or failing such succession, to the City of Lakeland;

(b) To promote the common good and general welfare of the City of Lakeland, Florida, its inhabitants, surrounding territories and its inhabitants, their civic or other enterprises by providing the aforesaid facilities;

(c) To borrow funds necessary to pay the cost of acquiring, constructing, maintaining and operating such properties and facilities, the indebtedness for which borrowed money may be evidenced by securities of this Corporation of any kind or character issued at any one or more times which may be either unsecured or secured by any mortgage, trust deed, or other lien upon any part or all of the properties and assets at any time then or thereafter owned or acquired by this Corporation;

(d) To conduct its business and affairs so as to vest in the Housing Authority or its lawful successor or successors, or failing such succession, to the City of Lakeland, all right, title and interest of this Corporation in or to all of its properties and assets (subject only to any liens, charges or encumbrances that may then exist thereon, and also subject to any rights or claims of any creditors of this Corporation), in order that the Housing Authority may acquire such properties and assets either as may be mutually agreed upon by this Corporation and the said Housing Authority, its lawful successor or successors, or failing such succession, in the City of Lakeland, Florida, provided that whenever this Corporation shall have fully paid all of its indebtedness incurred in connection with the issuance of its Bonds, notes or other evidences of indebtedness to be issued in order to finance the acquisition of real property and the construction of buildings, structures or improvements (otherwise than in connection with any refunding or refinancing of such bonds), then upon the request of the said Housing Authority, its lawful successor or successors, or failing such succession, in the City of Lakeland, Florida, this Corporation shall effect a transfer to the said Housing Authority, its lawful successor or successors, or failing such succession, in the City of Lakeland, all of the properties and affairs of the Corporation subject to any liens, charges or encumbrances which may then exist thereon, and also subject to any then-existing rights of any creditors of the Corporation;

(e) Without limiting the generality of the foregoing, this Corporation shall have all the powers, privileges, rights and immunities necessary or convenient for carrying out the purposes for which this Corporation is formed,

and the Trustees hereby claim for this Corporation all the benefits, privileges, rights and powers created, given, exercised or conferred by the provisions of all applicable laws of the State of Florida pertaining to non-profit corporations and any additions or amendments thereto.

#### ARTICLE IV

The Corporation is organized not-for-profit and shall not issue shares, and no part of the income or profits of said Corporation shall ever be distributed to any members, directors, or officers thereof.

ANTIQUE VI

This Corporation shall have a Board of Directors in which all power of the Corporation shall be vested and which shall consist of not less than five (5), in number, all of whom shall be duly qualified residents of and taxpayers of the City of Lakeland, Florida. The first Board of Directors shall be constituted of five (5) directors whose tenure in office shall be five, four, three, two and one years, respectively, or until their successors are elected. The first Board of Directors under these Articles, their addresses, and their respective tenures are as follows:

A subsequent director shall be elected annually by the then existing Board of Directors to replace the director whose tenure is then expiring, and shall hold office for five (5) years or until his successor is duly elected. All vacancies in the Board of Directors shall be filled for the unexpired term in the same manner.

The affairs of the Corporation are to be managed by a President, Vice President and Secretary, all of whom shall be elected from the membership.

of the Board of Directors. The officers shall serve until their successors are duly elected and qualified and the officers shall be elected annually by the Board of Directors from its membership. The officers shall be elected at the first meeting of the Board of Directors after the application for the Articles of Incorporation have been accepted by the Secretary of State of the State of Florida and thereafter on such anniversary date.

The officers who are to serve until the first election of officers under these Articles of Incorporation are as follows:

WESMAN WINSTEAD, JR. - President

MORRIS HARRIS - Vice President

HAROLD A. YERKIN - Secretary

The by-laws of this Corporation are to be made, altered, amended or rescinded by a majority vote of the Board of Directors.

#### ARTICLE VII

These Articles of Incorporation shall be amended by affirmative vote of the Board of Directors.

#### ARTICLE VIII

All of the assets of the Corporation shall be held in Trust for the purposes herein mentioned including the payment of all of the Corporation's liabilities. Upon dissolution of the Corporation all of its assets remaining after the payment of all of its liabilities shall vest in and be transferred to the Housing Authority or its lawful successor or successors, or failing such succession, in the City of Lakeland, Florida, without consideration of whatsoever kind or nature.

#### ARTICLE IX

The address of the registered office of the Corporation shall be: Lakeland-Polk Corporation, Inc., 2247 North Crystal Lake Drive, Lakeland, Florida, 33801.

#### ARTICLE X

The period of duration of this Corporation shall be perpetual.

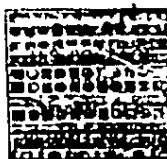

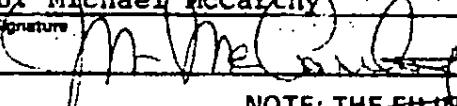
