ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

RIVER OAKS APARTMENTS CONDOMINIUM OWNERS' ASSOCIATION, INC.

The undersigned officers of River Oaks Apartments Condominium Owners' Association, Inc., a not for profit Florida corporation organized and existing to operate and govern River Oaks Apartments, Section A, a Condominium, according to the original Declaration of Condominium, thereof as recorded in the public records of Manatee County in O.R. Book 599, Page 380, et seq., and all amendments thereto, which encloses as an exhibit the original Articles of Incorporation thereof as originally recorded in the public records of Manatee County in O. R. Book 599, Page 412, et seq. including all amendments thereto, hereby certifies that the following amendments to the Articles of Incorporation Articles were duly adopted in the manner provided in the governing documents of the Association and applicable law at a duly convened meeting.

(Additions indicated by <u>underlining</u>, deletions by strike-through)

1. Amendment to Article VIII of the Articles of Incorporation, to read as follows:

ARTICLE VIII

Amendments

Amendments to the Articles of Incorporation shall be proposed and adopted in the following manner:

- 8.1 Notice of the subject manner of a proposed amendment shall be included in the notice of any meeting at which a proposed amendment is considered.
- 8.2 A resolution for the adoption of a proposed amendment may be proposed either by the board of directors or by the members of the Association. Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, providing such approval is delivered to the secretary at or prior to the meeting. Except as elsewhere provided,
- (a) Such approvals must be by not less than 2/3 of the entire membership of the board of directors and by not less than 2/3 60% of the votes of the entire membership of the Association; or
- (b) By not less than 80% 60% of the votes of the entire membership of the Association.

- 8.3 Provided, however, that no amendment shall make any changes in the qualifications for membership nor the voting rights of members, nor any change in Section 3.3 of Article 3, without approval in writing by all members and the joinder of all record owners of mortgages upon the condominium. No amendment shall be made that is in conflict with the Condominium Act or the Declaration of Condominium.
- 8.4 A copy of each amendment shall be certified by the Secretary of State and be recorded in the Public Records of Manatee County, Florida.

2. Amendment to Article IX of the Articles of Incorporation, to read as follows:

ARTICLE IX

By-Laws

The By-Laws of this corporation shall be amended, altered or rescinded in the following manner:

- 9.1 Notice of the subject matter of a proposed amendment shall be included in the notice of any meeting at which a proposed amendment is considered.
- 9.2 A resolution adopting a proposed amendment may be proposed by either the Board of Directors of the Association or by the members of the Association. Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, providing such approval is delivered to the secretary at or prior to the meeting. Except as elsewhere provided, such approvals must be either by:
- (a) Not less than 75% of the entire membership of the Board of Directors and by not less than 75% 60% of the votes of the entire membership of the Association: or
 - (b) Until the first election of directors, by all of the directors.
