

**AMENDMENT TO ARTICLES OF INCORPORATION  
FOR  
CAPE CORAL BABE RUTH LEAGUE, INC.  
(A Corporation Not-for-Profit)**

The following Amendment to the Articles of Incorporation of Cape Coral Babe Ruth League, Inc., a Florida corporation not-for-profit (referred to herein as the "Corporation") was adopted by a majority of the Board of Directors and approved by a majority vote of the Membership Corporation, present, in person or by proxy, at a special meeting of the Corporation duly called for such purpose, as of the 9 day of ~~January~~ <sup>FEBRUARY</sup>, 2004:

1. Article II of the Articles of Incorporation of the Corporation is hereby amended, in its entirety to read, as follows:

**Article II- Purposes**

The general nature of the objects and purposes of this Corporation shall be: To provide a Babe Ruth Baseball program for the youth of Cape Coral.

This Corporation is organized exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law) or (b) by a Corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue Law).

Upon the dissolution of this Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future federal tax code, or shall be distributed the Federal government, or to a state or local government for public purpose. Any such assets not so disposed of shall be disposed by the Court of Common Pleas of the county in which the principal office of the Corporation is then located, exclusively for such



purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

2. In all other respects, the Articles of Incorporation of the Corporation shall remain in full force and effect.


