ARTICLES OF INCORPORATION ST. ARMANDS ASSOCIATION, INCORPORATED

ARTICLE V - BOARD OF GOVERNORS

Section 1. The government and management of the Association shall be vested in a Board of Governors consisting of not less than five (5) ten (10) members and not more than eleven (11) fifteen (15) members; provided however, that no more than three members at any time shall be other than Regular Members who are residential property owners. To be eligible for election to the Board Regular Members must have been residential property owners for at least two (2) years. However, persons who have owned residential property for less thant 2 years may be considered for a one (1) year term as a Provisional Board Member in order that they can become aware of the Board's activities, and the Board can become acquainted with them.

Section 2. The Board of Governors of the Association shall be elected by the membership at the annual meeting hereinafter provided for, and shall serve for terms of two (2) three (3) years or until their successors have been elected.

ARTICLE VI - OFFICERS

Section 1. The Officers of the Association shall be: President, First Vice-President, Second Vice-President, Secretary, and Treasurer. There may also be such other Officers as the Board may from time to time determine. These Oofficers shall be elected by the Board of Governors from among the members of the Board as soon as after each annual meeting of the Association as may be practicable, and shall serve until the next annual meeting.
