ARTICLES OF AMENDMENT TO AMENDED ARTICLES OF INCORPORATION OF THE CENTER FOR DRUG FREE LIVING, INC.

THE UNDERSIGNED, of THE CENTER FOR DRUG FREE LIVING, INC., a Florida not for profit corporation (the "Corporation"), for and on behalf of the Corporation, hereby executes these Articles of Amendment to the Amended Articles of Incorporation of the Corporation:

ARTICLE FIRST: The name of the Corporation is THE CENTER FOR DRUG FREE LIVING, INC., and the Corporation's Florida document number is 723542.

<u>ARTICLE SECOND</u>: <u>ARTICLE III</u>: <u>MEMBERSHIP</u> of the current Amended Articles of Incorporation is hereby deleted in its entirety and restated as follows:

"ARTICLE III

<u>MEMBERSHIP</u>

"ARTICLE X

AMENDMENT OF ARTICLES

The Articles of Incorporation of the Corporation may only be amended by a majority vote of all Directors eligible to vote (and not merely a majority of those present at a meeting) at any meeting called for that purpose, provided that written notice of the proposed action and meeting has been given or mailed/e-mailed to the Directors at their last known address/e-mail address at least ten (10) days prior to the meeting to vote on the amendments to the Articles of Incorporation. The written notice shall contain the date, time and location of the meeting, and a description of the subject matter of the proposed amendment. Where possible, the actual proposed language of the amendment shall also be included."

ARTICLE SIXTH: The foregoing amendments were approved and adopted by the Board of Directors of the Corporation by the required two-thirds (2/3) vote of the members present at a meeting called for that purpose on the 25th day of July, 2013, after the required notice was given.
