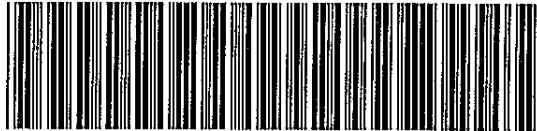



Pursuant to the provisions of Florida Statutes sections 617.1006, the undersigned, Florida nonprofit corporation adopts the following Articles of Amendment to its Articles of Incorporation.

**FIRST:** Amendment(s) adopted:

**Article 1 is hereby amended as follows:**

The name of the corporation, formerly First Baptist Church of Deltona, Inc., shall be FAITH BAPTIST CHURCH OF DELTONA, INC.

**SECOND:** The date of adoption of the Amendment was October 1, 2003
