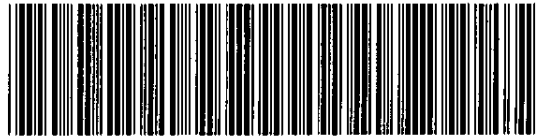



These Articles of Dissolution shall be effective on March 31, 2010.






