AMENDED ARTICLES OF INCORPORATION
OF

ALACHUA COUNTY HISTORICAL SOCIETY, INC.

A FLORIDA CORPORATION NOT FOR PROFIT.

NOW TO BE KNOWN AS

THE ALACHUA PRESS, INC.

A FLORIDA CORPORATION NOT FOR PROFIT.

WE, the undersigned President and Secretary of Alachua County Historical Society, Inc., do hereby certify that the Articles of Incorporation are amended as follows:

ARTICLE I.

The name of the corporation shall be THE ALACHUA PRESS, INC.

ARTICLE II.
PURPOSE

The purpose of this corporation is to publish books and pamphlets dealing the history, culture and environment of Alachua County and North Central Florida.

ARTICLE III.
MEMBERSHIP

The members of the corporation shall be the members of the Board of Directors of the Matheson Historical Center, Inc., A Florida Corporation not for profit or its successor.

ARTICLE IV. BOARD OF DIRECTORS

The affairs of the corporation shall be managed by a Board of Directors consisting of at least 5 but not more than 7 members, the number shall be set in the by-laws, who shall be elected by the members for such terms as are set in the by-laws.

ARTICLE V. OFFICERS

The officers of the corporation shall be a President, Vice-President, Secretary and a Treasurer who shall be members of the Board of Directors and elected by the Board of Directors. The officers shall have such duties and serve such terms as provided in the by-laws:

ARTICLE VI.

The corporation shall exist perpetually.



ARTICLE VII NON-STOCK CORPORATION

The corporation shall be non-stock, and no dividends shall be declared or paid to the members.

ARTICLE VIII. DISTRIBUTION OF ASSETS UPON DISSOLUTION

This corporation is not organized for a pecuniary profit. It shall not have any power to issue certificates of Stock or declare dividends, and no part of its net earnings shall inure to the benefit of any member, director or individual. In the event of dissolution, the residual assets of the corporation will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding Sections of any prior or future law, or to the Federal, State or local government for exclusive public purposes.

ARTICLE IX. CORPORATE OFFICE

The corporation's office shall be located at 513 East University Avenue, Gainesville, Florida 32601, and the Registered Agent is John K. Mahon whose address is 4129 SW 2nd Avenue, Gainesville, Florida 32607.

ARTICLE X. AMENDMENTS TO ARTICLES OF INCORPORATION AND BY-LAWS

The Articles of Incorporation may be amended and the By-Laws made and amended by a majority vote of the members at a regular or specially called (with at least 15 days notice) meeting.

The remainder of the Articles of incorporation not amended herein are hereby deleted.

This amendment is approved by the Corporation on April 5, 1999.
