

AMENDMENT TO THE ARTICLES OF INCORPORATION OF LUCAYA DELRAY, INC.

(Additions shown by "underline", deletions shown by "strikeout", unaffected text shown by "* * *")

Article IX, Section 2, (a) Such approvals must be by the majority of the entire membership of the Board of Directors and by the <u>affirmative vote at a duly noticed and conducted meeting</u>, or the <u>written consent</u>, of not less than two-thirds (2/3) <u>majority</u> of the <u>eligible voting interests of the entire</u> membership of the Association (i.e not less than two-thirds (2/3) of the eligible voting interests of the owners of all the apartments in Delray Estates Phases I through IV Condominiums, inclusive). represented at a meeting at which a quorum is present.
