ARTICLE 9. Amendments

- **9.1) Amendments** Subject to the provisions of Section 9.2 of this Article 9, Amendments to the Articles of Incorporation shall be proposed and adopted in the following manner:
 - (b) A resolution for the adoption of a proposed amendment may be proposed either by the Board of Directors or by the members of the Association. Except as elsewhere provided, approvals must be by not less than 75% two-thirds (2/3rds) of the members of the Association voting, in person or by proxy, at a membership meeting of the Association at which a quorum is present called in whole or in part for that purpose.
