ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF BEACH HARBOR CLUB ASSOCIATION, INC. DOCUMENT NUMBER OF CORPORATION: 724181

Pursuant to provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

- 1. The Articles of Incorporation have been amended as follows: (text in strike-through format indicate deletions; <u>underlined</u> text indicates additions)
- Section 2.1 The purpose for which the Association is organized is to provide a condominium association under Chapter 718 711, Florida Statutes, for the operation of Beach Harbor Club, a condominium, under the Declaration recorded in Official Records Book 854, at page 1080, as it may be amended from time to time, of the public records of Sarasota County, Florida.
- Section 5.1 The affairs of the Association will be managed by a board consisting of the number of directors determined by the Bylaws, but not less than three directors, and in the absence of such determination shall consist of three directors. Directors shall be need not be members of the Association unless otherwise provided in the Bylaws.
