1. Article IX, Section B of the Articles of Incorporation is hereby revised, to read in its entirety as follows:

(insertions are underlined, and deletions of prior language are struck-through)

- "B. A resolution for the adoption of a proposed amendment may be proposed either by the Board of Directors or by the members of the Association. Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, provideding such approval is delivered to the secretary at or prior to the meeting. Except as elsewhere provided.
- 1. such approvals must be <u>done by mailed written consent or by voting at a meeting</u> by not less than <u>75% 66%</u> of the entire membership of the Board of Directors and by not less than <u>75% 66%</u> of the votes of the entire membership of the Association."

 2. by not less than 80% of the votes of the entire membership of the Association."
- 2. Article III, Para. 6 of the Articles of Incorporation shall be revised, to read in its entirety as follows:

(insertions are underlined, and deletions of prior language are struck through)

"6. To make and amend reasonable regulations regarding the use of the property of the condominium; provided, however, that-all-such-regulations-and-their-amendments-shall be-approved by not-less than-seventy-five percent (75%) of the votes-of the entire membership of the Association before such shall become effective."

THE FOREGOING AMENDMENTS were adopted by not less than seventy-five percent (75%) of the Board of Directors and not less than seventy-five percent (75%) of the votes of the entire membership, pursuant to Article IX, Section B of the Articles of Incorporation, and the number of votes cast was sufficient for approval.
