AMEND ARTICLE 2, add to existing Article 2:

2. Said organization is organized exclusively for charitable purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501©(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Said organization shall also build, manage, and lease housing to individuals in Marion County, Florida.

ADD ARTICLE 14:

14. Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501©(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
