CERTIFICATE OF AMENDMENTS TO THE ARTICLES OF INCORPORATION OF MARINER CAY I ASSOCIATION, INC.

The Articles of Incorporation of Mariner Cay I Association, Inc. were filed with the Secretary of State on October 12, 1972. They were also recorded in the Public Records of Martin County, Florida, at Official Records Book 346, Page 61 et.seq. The same Articles of Incorporation are hereby amended by the members, and the number of votes cast for the amendment was sufficient for approval at a special meeting held on November 7, 2023 which is the date of adoption by the membership entitled to vote.

1. Article 3.2 (a) is hereby amended as follows:

- 3.2 The Association shall have all of the powers and duties set forth in the Condominium Act except as limited by these Articles and the Declaration of Condominium establishing the Condominium to be hereafter recorded, and all of the powers reasonably necessary to implement and effectuate the purposes of the Association and to operate the Condominium pursuant to the Declaration of Condominium, as it may be amended from time to time, including but not limited to the following:
- (a) To make and establish reasonable rules and regulations governing the use and maintenance standards of Units. Common Elements and Limited Common Elements in the Condominium, as said terms may be defined in said Declaration of Condominium; provided, however, that all such regulations and their amendments shall be approved by not less than a majority of the members of the Board.

2. Article 9.2 (a) (1.) and (2) are hereby amended as follows:

9.2 A resolution for the adoption of a proposed amendment may be proposed (a) by the Board of Directors of the Association acting upon vote of a majority of the directors or (b) by a majority of the members of the Association, whether meeting as members or directors or by instrument in writing signed by them. Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, providing such approval is delivered to the secretary at or prior to the meeting. Except as elsewhere provided, the adoption of any proposed amendment must be approved by

Not less than a majority of the entire membership of the Board of Directors and by a vote of the members of the Association, the vote required to approve an amendment is as follows:

- (1.) at least a majority of all owners must cast a vote, and
- (2.) of those who cast a vote, at least sixty-six and two thirds percent (66 2/3%) of those members must vote to approve.

- 3. The foregoing amendments to the Articles of Incorporation were adopted by the members by a vote sufficient for approval.
- 4. All provisions of the Articles of Incorporation are herein confirmed and shall remain in full force and effect, except as specifically amended herein.
