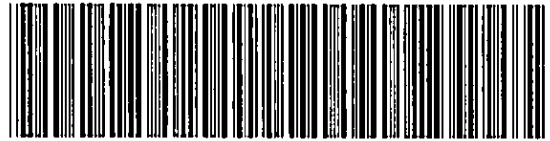

ARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION OF  
HILLCREST EAST NO. 23, INC.

The undersigned officers of **Hillcrest East No. 23, Inc.** do hereby certify that the following amendment to the Articles of Incorporation of said corporation is a true and correct copy as amended, pursuant to Article XI thereof, by the membership at a duly called and noticed meeting of the members held December 17, 2018. The amendment was adopted by the members and the number of votes cast for the amendment was sufficient for approval.

ARTICLE XVI

The Corporation shall have all the powers set forth and described in Chapter 617.0240302, Florida Statutes, as same may be amended or renumbered from time to time, together with those powers conferred by the aforesaid Declaration of Condominium, this Charter and any and all lawful By-Laws of the Corporation including but not limited to the power to borrow money and secure its obligations by mort and pledge of income. In addition to all of the foregoing, this Corporation shall have right and power (a) to enter into agreements whereby it acquires the right of Members, along with other non-Members of this Corporation, to lease recreational and club facilities, which are not a part of the Condominium; (b) to contract with a third party for the management of the Condominium or to delegate to such third party as manager the powers and duties of it and its Officers and Directors, except such powers and duties which are specifically provided for in the provisions of these Articles of Incorporation or the By-Laws of the Corporation, and (c) to enter into the Agreement of User with The Hollywood Beach Hotel Development Co., Inc. and/or Hillcrest East No. 24, Inc. hereto and made a part hereof as Exhibit "BB", and (d) to be a party to the Agreement (Swimming Pool) between The Hollywood Beach Hotel Development Co., Inc. and Hillcrest Management Company, copy of which is attached hereto as Exhibit "CC" and to enter into the Agreement (Recreational Lease) in the form attached hereto and made a part hereof as Exhibit "DD" and (e) to enter into the Management Agreement between Hillcrest Management Company and Hillcrest East No. 23, Inc. in the form attached hereto and made a part hereof as Exhibit "EE".

be bound by the Declaration of The Hollywood Beach Hotel Development Co., Inc. unto Atlantic Federal Savings and Loan Association of Fort Lauderdale relating to the use of the swimming pool referred to in (c), and (g) to become a member of The Hillcrest Board of Governors and to bind the Members of this Corporation to the actions taken by said Board of Governors.

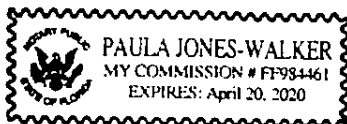
