Amended Articles of Incorporation of The St. Andrews Club, Inc., a non-profit corporation originally organized: under the laws of the State of Florida, pursuant to Florida Statutes, Chapter 617, on December 1, 1972, as follows:

ARTICLE 11

The general nature, objects and purposes of this Club as organized and incorporated are as follows:

(a) To establish, maintain and operate a golf, tennis and beach club, for the benefit, amusement, recreation and <u>croquet</u> and other conveniences

entertainment of its members and their guests, and to provide, operate and maintain a par three golf course, tennis courts, swimming pool, club houses, and other conveniences and, generally to afford its members all the usual croquet lawn

privileges, advantages, conveniences and accommodations of a golf, tennis and beach club.

ARTICLE III

*3. The membership of this Club shall consist of Homeowner Members, Associate Members and such other classes and Social Members.

of members as may be provided for in the By Laws. All equity interest and voting shall be vested exclusively in the Homeowner Members, except that Associate Members and Social Members shall be entitled to vote as a separate class on assessments for capital improvements to which they are subject.

Homeowner Memberships may be transferred only with the approval of the Board of Governors.

**8. The membership shall be limited to three hundred and fifty (350) comprised of one hundred and thirty-six (136)

three hundred and seventy-five (375)

Homeowner Members and a total of two hundred and fourteen (214) Associate Members and Social Members two hundred and thirty-nine (239)

of which not more than forty (40) shall be Social Members.
